

Enrollment Agreement

By signing this agreement, I the student, acknowledges that I have read and understand all of the requirements and guidelines of the Application for the **Authentic Pilates Education International teacher training program**.

1; Limitation of liability

2; Release and indemnity

In consideration of the entitlement to engage in Pilates activities, you hereby: release and forever discharge **APEI** and the **Host Studio**, it's proprietor, employees, agents or contractors from all actions, suits, proceedings, claims, demands, losses, damages, penalties, fines, costs and expenses, however arising that you may have had but for this release arising from or in connection with your involvement in activities of the **host studio** or being on the business premises and Indemnify the business **APEI** and **host studio**, to the extent permitted by law in respect of any actions, suits, proceedings, claims, demands, losses, damages, penalties, fines, costs and expenses, arising as a result of or in connection with your involvement in activities of the business **APEI and host studio**, or being on the business premises and whether caused or contributed to, directly or indirectly, by any act of negligence to the fullest extent permitted by law, breach of duty, default and/or omission on the part of the **APEI and host Studio** or otherwise.

3.APEI reserves the right to terminate any student from the Program for conduct which violates **APEI's** policies or the policies of any Certification or Training Center involved in the Program, or which conduct qualifies as unprofessional conduct deemed inappropriate as determined by **APEI** in its sole and absolute discretion. Students must be able to physically exercise in seminars and apprenticeship to be eligible for certification. **APEI** reserves the right to suspend students who cannot participate fully in the Program.
